1 x double socket for 240v power only (per single booth)

4 x razors

2 x 500ml bottles of water for use with cleaning

1X LARGE ROLL PLENTY BRAND kitchen roll

20m roll of cling film.

Assorted ink cups and water cups along with tongue dispensors

1 x plastic tablecloth for your front table (if not required please return)

1 x sharps bin container

bin bags for clinical waste and for normal waste (**Do not mix clinical waste with your normal waste**)

2 x chairs and 1 large tressel table 1800mm x 600mm

8 x satchets of Yayo water solution

1 x small table for tattoo artist to use for working off (where possible we have 100)

Please note we recommend you bring spare disposables if you think what we supply will not be enough for your time here.

When sending this form back please include a copy (scan/photograph) of all artists health certificate/local registration. Please Supply **two images per artist** so we can use these to promote you, send these back to [info@newmarkettattooconvention.co.uk](mailto:info@newmarkettattooconvention.co.uk) with names of the artists so we can ensure they are done correctly.

Payment will be required once you have sent back this form, for our terms and conditions please visit our website.

## **TERMS & CONDITIONS – ARTISTS & TRADERS**

**Effective Date: May 2026**

**By applying for or booking a space at Newmarket Tattoo Convention, all artists and traders agree to the following Terms & Conditions.**

### **1. BOOKINGS**

**All artist and trader bookings are subject to approval by the event organisers. Submission of an application does not guarantee acceptance into the event.**

**Spaces will only be confirmed once payment has been received in full unless otherwise agreed by the organisers.**

### **2. PAYMENTS & REFUNDS**

**All payments made for artist or trader spaces are strictly non-refundable.**

**In the event of cancellation by the artist or trader for any reason, no refunds will be issued under any circumstances.**

**Bookings may not be transferred, resold or shared without prior written permission from the organisers.**

### **3. EVENT CANCELLATION**

**In the unlikely event that Newmarket Tattoo Convention is postponed, cancelled or affected by circumstances outside of the organisers' control, including but not limited to extreme weather, venue issues, government restrictions or force majeure, the organisers reserve the right to reschedule the event.**

**The organisers will not be held responsible for any personal costs, travel expenses, accommodation costs or loss of earnings incurred by artists or traders.**

### **4. CONDUCT**

**All artists and traders are expected to conduct themselves professionally and respectfully throughout the event.**

**The organisers reserve the right to remove any individual or business from the event without refund if their behaviour is deemed inappropriate, unsafe, abusive or damaging to the reputation of the event.**

### **5. HEALTH & SAFETY**

**All tattoo artists are fully responsible for complying with current health, hygiene and licensing regulations.**

**Artists must ensure all equipment, procedures and working practices meet UK health and safety standards.**

**Traders are responsible for ensuring their products and displays comply with all relevant regulations and safety requirements.**

**Newmarket Tattoo Convention and its organisers accept no responsibility for loss, theft or damage to personal belongings, equipment, stock or vehicles during the event.**

**All artists and traders attend and operate at the event at their own risk.**

## **7. SET UP & BREAKDOWN**

**All exhibitors must follow allocated setup and breakdown times provided by the organisers prior to the event.**

**Spaces must be left clean and clear at the end of the event weekend.**
