By applying for or booking a space at Newmarket Tattoo Convention, all artists and traders agree to the following Terms & Conditions.

1. BOOKINGS

All artist and trader bookings are subject to approval by the event organisers. Submission of an application does not guarantee acceptance into the event.

Spaces will only be confirmed once payment has been received in full unless otherwise agreed by the organisers.

2. PAYMENTS & REFUNDS

All payments made for artist or trader spaces are strictly non-refundable.

In the event of cancellation by the artist or trader for any reason, no refunds will be issued under any circumstances.

Bookings may not be transferred, resold or shared without prior written permission from the organisers.

3. EVENT CANCELLATION

In the unlikely event that Newmarket Tattoo Convention is postponed, cancelled or affected by circumstances outside of the organisers' control, including but not limited to extreme weather, venue issues, government restrictions or force majeure, the organisers reserve the right to reschedule the event.

The organisers will not be held responsible for any personal costs, travel expenses, accommodation costs or loss of earnings incurred by artists or traders.

4. CONDUCT

All artists and traders are expected to conduct themselves professionally and respectfully throughout the event.

The organisers reserve the right to remove any individual or business from the event without refund if their behaviour is deemed inappropriate, unsafe, abusive or damaging to the reputation of the event.

5. HEALTH & SAFETY

All tattoo artists are fully responsible for complying with current health, hygiene and licensing regulations.

Artists must ensure all equipment, procedures and working practices meet UK health and safety standards.

Traders are responsible for ensuring their products and displays comply with all relevant regulations and safety requirements.

6. LIABILITY

Newmarket Tattoo Convention and its organisers accept no responsibility for loss, theft or damage to personal belongings, equipment, stock or vehicles during the event.

All artists and traders attend and operate at the event at their own risk.

7. SET UP & BREAKDOWN

All exhibitors must follow allocated setup and breakdown times provided by the organisers prior to the event.

Spaces must be left clean and clear at the end of the event weekend.
